Use your IRA instead of savings to increase your return.

- In contrast to a savings account, investing with funds from your individual retirement account (IRA) may be either tax free or tax deferred.
- Investing using IRA's has been allowed since their inception and is widely done. Your gains may be either tax deferred or tax free, depending on the type of IRA you use to make the investment.
- IRS Publication 590 (dealing with IRAs) states what investments are allowed. They include stocks, bonds, mutual funds, real estate, mortgages, private placements or even livestock are acceptable provided that the IRS rules governing retirement plans are followed.
